教学大纲及教学日历 SYLLABUS

15. 教学目标 Course Objectives

我们的精神世界强烈地受到社会文化因素的影响。本课中，我们将揭示这些因素如何造成精神困境，如何影响我们对精神病的解读和治疗。通过环游世界，着重思考文化因素如何影响精神患者的体验，现代医学研究以及医药怎样改变我们对精神病的理解。我们还会探讨经济结构、社会变迁与精神健康的密切关系，跟精神疾病有关的伦理和哲学问题也将贯穿整个课程。除了获得对精神与文化更丰富的理解，学生在课程中也会练习一些学术技巧，包括准备英文小品文以及口语报告，搜索以及引用学术资源，以利于将来更有效地融入国际学术环境。学生会进行一个基于采访的研究，进一步探索精神健康。 Our minds are powerfully shaped by social and cultural forces. In this course, we will ask how these forces create psychological distress, and how they shape the way in which we understand and treat mental illness. We will travel around the world, seeing how cultural forces affect how people interpret and experience mental illness. We will think about how modern medical research and pharmaceuticals have changed our view of mental illness. We will think about the connection between economic forces, social change, and psychological stress. Throughout, we will engage with ethical and philosophical issues related to mental health. In addition to learning about cultural and social issues in psychology and psychotherapy, students will also practice academic skills that will help them to participate effectively in an international academic environment. These skills include preparing brief English language essays and oral presentations, searching for academic sources, and citing sources in written work. Students will complete an interview-based research project, in which they will investigate an issue related to mental health.

Lecture 1: Introductions / 介绍 (2-credit hours)

What is mental health?

Goals of the course

Self-introductions

We will begin by asking what students know about mental health, and how they think it may be influenced by social and

cultural forces. Afterwards, I will explain the goals of the course. Finally, we will each introduce ourselves.

Lecture 2: Interpreting Experience / 经验的解读 (2-credit hours)

Magic, ritual, and the placebo effect

Rationality and cultural logics

Healers have existed long before contemporary medicine was developed. In many societies, medicine, ritual, and magic are closely connected. In this class, we will discuss what the degree to which this kind of healing is 'rational'. We will also discuss the healing power of ritual.

Lecture 3: Psychosis and Experience / 精神病的体验 (2-credit hours)

The placebo effect

Belief and efficacy

The experiences of mentally ill people are greatly shaped by their cultural and social contexts. Focusing on the example of schizophrenia, we will see how people use cultural symbols to interpret their own emotions, thoughts, and relationships, and how this interpretive work shapes mental health. In addition, we will ask how social stresses can produce mental illness.

Lecture 4: What's Normal? / 什么是正常? (2-credit hours)

Normality and disease

Interpreting illness

While some kinds of illness are recognized as disease, others may be seen as moral tests, individual difference, or even as gifts from the gods. By looking at examples of physical and mental suffering from around the world, we will examine how people in different societies have defined illnesses in different ways.

Lecture 5: Psychotherapy / 精神治疗 (2-credit hours)

What is healing?

Narratives and the self

We will learn about the history of psychiatric and psychological treatment. We will then ask how speaking to a psychologist is supposed to produce a healing effect. Finally, we will think about how psychotherapy changes the way in which people understand themselves.

Lecture 6: Psychiatric Power / 精神医学的权力 (2-credit hours)

Psychological expertise

Deviance and control

Psychologists and psychiatrists have great power to tell us who we are. In fields such as law, education, and social work, their opinions can affect people's lives. How should we think about the nature of psychological knowledge, and its social uses?

Lecture 7: Biomedicine and Epistemology / 生物医学与认识论 (2-credit hours)

Reductionism

Disease models

Contemporary medicine presents itself as a highly scientific system. However, scientific knowledge is itself shaped by

cultural and social forces. We will discuss how medical research, theory, and practice are shaped by these forces.

Lecture 8: Medicalization / 医疗化 (2-credit hours)

Psychopharmaceuticals

Drug marketing

Problems in many areas of life are now considered medical issues. When they make decisions about nutrition, exercise, parenting, and relationships, many people today see themselves as patients and seek advice from medical experts. Companies selling medical treatment also encourage people to believe that medicine can cure not only current diseases, but also be used to manage future risks and to seek happiness.

Lecture 9: Family, Social Support, and Stress / 家庭, 社会支持, 与压力 (2-credit hours)

Culture and family structure

Developmental psychology

Children's cognitive and emotional development is shaped by their parents. How do different kinds of families, and different forms of parenting, affect mental health? We will read about how parents in different cultures have very different ideas about how children should be educated.

Lecture 10: Economics, History, and the Self / 经济, 历史, 与自我 (2-credit hours)

Structural violence

Social support, social enabling

The social contexts in which we live shape our mental health. We will think about how large social structures affect the stresses that people face in their daily life. We will also discuss how small social groups, such as families or local communities, can promote mental health, or exacerbate distress.

Lecture 11: Depression / 抑郁 (2-credit hours)

Self-actualization

Genes and environments

Depression has become a major epidemic. But scholars are not sure how to define what it is. We will see how psychiatrists, psychologists, medical researchers, and social scientists have analysed depression from very different perspectives.

Lecture 12: Culture and Personality / 文化与人格 (2-credit hours)

What is culture?

Culture and identity

We will look at research from North America and East Asia that shows that culture profoundly shapes our psychology. Turning to statistical research, we will see that rates of mental disorder differ worldwide. Finally, we will examine theories about the connection between culture and mental health.

Lecture 13: Personality and Social Change / 人格与社会变迁 (2-credit hours)

Individualization

Life Projects

We will discuss the concept of 'individualization': this describes a process by which people have become less connected to particular social groups, and more responsible for determining their own identity. Under these conditions, people often

identify themselves by their choices and their projects: this can be a very stressful situation.

Lecture 14: Technology, Identity, and Mental Health / 科技, 个人身份, 与精神健康 (2-credit hours)

Therapy devices and apps

The internet and the self

The internet has become a major influence on our mental life. How does this technology shape our identity? What dangers does it pose to our mental health, and what opportunities does it give us to find treatment?

Lecture 15: Wellness / 整体健康 (2-credit hours)

Lifestyle politics

Technologies of the self

Many people today are interested not only in treating mental illness, but also in promoting mental health. What ways do we have to stay healthy and happy in our everyday lives?

Lecture 16: Reflections / 反省 (2-credit hours)

Each student will have a few minutes to explain their research projects: their research question, what group of people they interviewed, and what they learned. Then, we will summarize and review the course contents. We will ask how social science perspectives can affect the practice of mental health care.
